

**Wonderful Pistachios “Destroy Ernie’s Evidence” Promotion
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

BY ENTERING THE PROMOTION, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

Eligibility - The Wonderful Pistachios “Destroy Ernie’s Evidence” Promotion (the “Promotion”) is open only to legal residents of 50 U.S. states and D.C., who are 18 years or older (or 19 for residents of AL and NE) at the time of entry. Void where prohibited by law. No purchase necessary to enter the Promotion. Employees of Wonderful Pistachios & Almonds LLC, 11444 W. The Promotion is subject to all applicable federal, state, municipal, and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 1. When to Enter** - The Promotion begins on March 13, 2017 at 12:00:00 AM Eastern Time (“ET”) and ends on June 30, 2017 at 11:59:59 PM ET (the “Promotion Period”).

The Promotion consists of two separate elements: (1) the bi-weekly Promotion portion (“Bi-Weekly Prize Pool”); and (2) the grand prize Promotion portion (“Grand Prize Pool”).

The Bi-Weekly Prize Pools will be broken out into eight (8) separate entry pools based on the “Destroy Ernie’s Evidence” chapter releases (each, a “Chapter”), and will run per the Bi-Weekly Prize Pool chart below. 2. **How to Enter** - To enter, log on to www.helpErnie.com to complete and submit your registration by following the on-screen registration requirements. Upon submitting your initial registration, you will receive one (1) entry into the Grand Prize Pool and qualify to win all other prizes. Limit one (1) registration per person/email address.

Then after you have registered, during each Bi-Week, log onto the Website and play that Bi-Week's Chapter and if you participate in each Chapter's puzzle or game, you will receive one (1) entry into that Bi-Week's Bi-Weekly Prize Pool. Promotion, each entrant agrees that the Sponsor and/or Administrator has the right to contact the entrant by phone, direct message, or email accounts provided on the Entry Form to administer and fulfill this Promotion.

4. **Winners Selection** – The total number of Winners per Bi-Weekly Prize Pool are set forth in the Chart above, for a total of 18 Bi-Weekly Prize Pool Winners, who will be randomly selected on the Random Drawing dates set forth in the Chart above, by Administrator from among all eligible Entries received in each Bi-Weekly Prize Pool. Then, on or about July 1, 2017, one (1) Grand Prize Pool winner will be selected via random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received.

Bi-Week Chapter 5: One (1) winner will receive a \$10,000.00, awarded in the form of a check. ARV: \$10,000.
